

## SCHOOL HEARING SCREENING: STATE LAWS AND GUIDELINES

This document provides an overview of state school hearing screening laws and regulations. It is presented to guide members on requirements that may affect their practice. There is no single federal mandate for childhood hearing screenings. However, current federal legislation supports the goal of identifying children most likely to have a hearing loss that may interfere with communication and affect academic performance and success. The Individuals with Disabilities Education Act (IDEA) 2004 requires school districts to identify, locate, and evaluate all children with disabilities [20 U.S.C. §1412(a) (3)]. It further requires states to have a comprehensive Child Find system that ensures standards for appropriately identifying infants and toddlers with disabilities that will reduce the need for future services [20 U.S.C. §1435 (a) (5)].
